Please be advised that as a Candidate for Community Council - Area/Subarea 11 at Large, you are required to file a Termination Report 90 days after becoming unopposed, elected or eliminated. The Campaign Treasurer's Report must be filed on the date shown below:


Reports shall be filed no later than 5 p.m. on the date designated; however, any report postmarked by the U.S. Postal Service no later than midnight on the date designated shall be deemed to have been filed in a timely manner.

Prior to disposing of surplus funds, a Candidate may be reimbursed by the Campaign for any previously reported contributions in part or in full.

Once a Candidate withdraws, becomes unopposed, is eliminated, or elected, he or she may expend funds from the campaign account to:

1. Purchase "thank you" advertising for up to 75 days thereafter
2. Pay for items which were obligated
3. Pay for expenditures necessary to close down the campaign office and to prepare final campaign reports
4. Dispose of surplus funds as provided in Section 106.141 F.S.

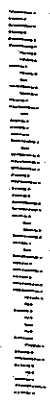
