**NOTICE OF LATE FILING - FINE DUE**

Our records reflect that the Campaign Treasurer's Report noted above was postmarked 8/14/2004 and therefore was filed 1 day(s) late. Accordingly, Section 106.07 of the Florida Status obligates the Miami-Dade County Elections Department to assess a fine against you in the amount of \$50.00.

This fine must be paid to our office within twenty (20) days of your receipt of this notice unless you choose to file an appeal to the Florida Elections Commission, 107 West Gaines Street, Collins Building Suite 224, Tallahassee, FL 32399-1056. The fine should be paid by check payable to the Board of County Commissioners. As provided by Section 106.07, the fine is not an allowable campaign expenditure and must be paid only from the personal funds of the candidate.

Section 106.07 also provides that you may appeal or dispute the assessed fine if unusual circumstances prevented you from filing on the designated due date. You may request, and will be entitled to, a hearing before the Florida Elections Commission which shall have the authority to waive the fine in whole or in part. You must make such a request within twenty (20) days of your receipt of this letter and must notify our office in writing of your intent to bring this matter before the Commission.
