NOTICE OF LATE FILING - FINE DUE - \$9.79

The Campaign Treasurer's Report which you filed with our office was received 10/20/2004 . Since this report was not filed on the appropriate filing date, you are being assessed a fine for each late day pursuant to the Florida Statutes, Chapter 106.07 (8) (b).

Our records reflect that this report was received on 10/20/2004. Therefore, since your report was 8 days late you are being fined at a rate of \$50.00 per day for the first 3 days late and thereafter, \$500.00 per day for each late day, not to exceed 25% of the total receipts or expenditures, whichever is greater, for the period covered by the late report. However, for the reports immediately preceding each primary and general election, the fine shall be \$500.00 per day for each late day, not to exceed 25% of the total receipts or expenditures, whichever is greater.

The fine due is based on 25% of your total expenditures of \$39.15 = \$9.79 . Said fine must be paid to our office at 2700 NW 27th Avenue, Miami, FL 33172 within 20 days of receipt of this notice unless appeal is made to the Florida Elections Commission, 107 West Gaines Street, Collins Building, Suite 224, Tallahassee, FL 32399-1050. The check should be made payable to the Board of County Commissioners in the amount of \$9.79.

Florida Statutes, Section 106.07(8)(b) states that you may appeal or dispute the assessed fine based upon unusual circumstances surrounding the failure to file on the designated due date. You may request and will be entitled to a hearing before the Florida Elections Commission, which shall have the authority to waive the fine in whole or part. Any such request must be in writing and must be received by the Elections Commission within 20 days of your receipt of this notice. Our office must be notified of your intent to bring this matter before the Commission.

Contents must be of a size and shape which fit the envelope and allow it to be securely sealed without damage. Cash or cash equivalent should not be shipped. Items of high intrinsic value should not be shipped in Letter Express packaging.

2. Place Airbill and necessary documentation in plastic sleeve. Seal sleeve.
3. Peel off backing of plastic sleeve.

5. Retain bottom copy of Airbill for your files.



Limitations of Liability
