You may request and will be entitled to a hearing before the Florida Elections Commission, which shall have the authority to waive the fine in whole or part. Any such request must be in writing and must be received by the Elections Commission within 20 days of your receipt of this notice. Our office must be notified of your intent to bring this matter before the Commission.
