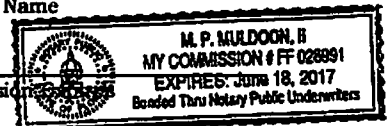

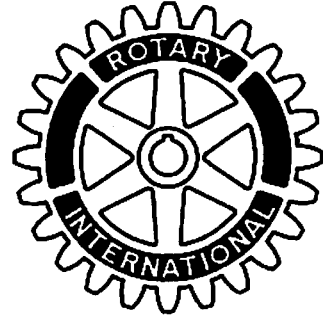

**Minutes of the Board of Directors Meeting
March 12, 2014 at 4 p.m.
Breckenridge Club House - Card Room**

Call to Order: Katy Errington called the board meeting to order at 4:00pm

Establish a Quorum: A quorum was established with Katy Errington, Vicki Weichel, Theresa Arellano, Steve Mitchell and Richard Amman.

Approval of last Board meeting minutes: Vicky made a motion to approve the minutes of the January 14, 2014 organizational meeting. The motion was seconded by Theresa. The motion was unanimously approved.

President's Report: Katy reported that the building painting was completed. The total cost to complete the painting came in at \$32,535, which was approximately \$300 under the contract price. Northern Contracting agreed to repair the concrete that they damaged with their equipment, repainted the mailboxes and replaced the light cover they damaged when pressure washing the carports.

Treasurer's Report: Steve Mitchell reported that based on current financials of January, the association had \$19,688 in operating cash funds at the end of the year 2013. Steve stated that delinquent accounts are not a problem and that 1 unit is still for sale that is past due. Overall the association is on sound financial ground.

Master Board Report:

Garth Errington reported that the Master Board of Breckenridge is attempting to reorganize the board by changing the date of the calendar year and by changing the size of the BOD from 16 to 7 board members. What benefits would be had by reducing the size of the BOD and what problems it causes are issues that Garth and Richard would like to get feedback from the residents to determine what stance he needs to present to the Master Board.

New Business:

Alarm Monitoring—Wireless vs Land Line: Steve reported that the fire alarm currently has 2 land phone lines that serve the existing fire alarms. Steve has worked with Cintas and came up with a wireless solution to replace the 2 phone landlines with a wireless unit. The total cost for the 2 land lines is \$1680.00 per year. The cost to purchase the wireless system will be \$1,935 for the first year and each year thereafter the cost will
