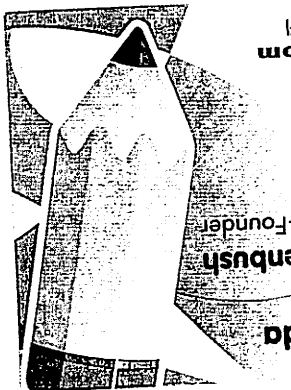



Strategic Plan – Focus Area 1: Inspire Students to Think and Learn:
presentation by Dr. Tim Ferguson, Executive Director, Student Related Services
