We regret to inform your campaign that the <u>re-validation</u> of candidate petitions submitted to this office on Monday, March 29, 2010, failed to yield the required number of valid signatures required for the office sought. The required number of valid signatures is 3,205. The re-validation of your candidate petitions yielded 3,029 valid signatures, or a shortage of 176 valid signatures.

We are officially rescinding the original Candidate Petition Certification issued by this office on April 5, 2010 and re-issuing the enclosed final Candidate Petition Certification.

The week of candidate qualifying is NOON, April 26, 2010 through Noon, April 30, 2010. Payment of the filing fee, and filing of all final candidate-qualifying forms must be completed prior to NOON, April 30, 2010.
