PETITION TO AMEND CITY OF MIAMI CHARTER/ PETICION PARA ENMENDAR LA CARTA CONSTITUTIVA DE LA CIUDAD DE MIAMI/PETISYON POU AMANDE CHAT VIL MIAMI A

We, the undersigned qualified electors of the City of Miami, Florida, in accordance with The Florida Constitution and Section 166.031 of the Florida Statutes, petition the City of Miami Commission to place a charter amendment on the next available city wide ballot that creates Section 52 of the Miami City Charter and creates Subsection (a) to state: **“The City is prohibited from assessing or collecting any additional parking fee or surcharge, at a rate that exceeds the sales tax rate in the State of Florida, in any parking structure or private parking facility in the City of Miami.”**
