**RE: Verification of petition signatures – Commissioner Manuel (Manolo) Reyes**

Dear Ms. McClain:

Enclosed are a batch of 438 petition forms for Commissioner Manuel (Manolo) Reyes. This petition is for a candidate running for the office of City of Miami District 4 Commissioner who seeks to use the petition process in lieu of a qualification fee.

For your information, Miami City Code Section 16-6(g) provides candidates with the option of using the petition process in lieu of a qualification fee. With this in mind, Section 16-6(g)(3) states, “[a] candidate must obtain the number of signatures of voters in the geographical area represented by the office sought equal to at least one percent (1%) of the total number of registered voters of that geographical area, as shown by the compilation by the Miami-Dade County Elections Department for the immediately preceding general election. Signatures may not be obtained until the candidate has filed an appointment of campaign treasurer and designation of campaign depository...”

According to the November 2, 2021 Miami-Dade Supervisor of Elections “District Demographic Analysis Report”, there were a total number of 41,908 registered voters in District 4. Furthermore, please note that Commissioner Reyes filed his appointment of campaign treasurer and designation of campaign depository form with the Office of the City Clerk on November 1, 2022. **Taking into account the information referenced above, the verification of 420 valid signatures is required for the petition to be sufficient.** For your information, the deadline for all petition forms to be submitted to the City Clerk was Friday, August 11, 2023.

Miami City Code Section 16-6(g)(5) states, “[N]o later than the 7<sup>th</sup> day before the first day of the qualifying period, the City Clerk shall determine whether the required number of signatures has been obtained and shall notify the candidate.” Therefore, the last day to provide a certificate certifying the number of valid signatures to me is Friday, September 1, 2023. When determining the validity of the petitions, please use FAC IS-2.045(5) “Verification of Signatures.”

Please return this batch of original petition forms to me along with a certificate certifying the number of valid signatures before the deadline indicated above.
