In May 2011, they welcomed their first daughter, Mirentxu Cristina Lago and in August 2014, their second daughter Catalin Maria Lago. In his professional career, Vice Mayor Lago is an executive at a distinguished management and design firm which focuses on commercial construction and specializes in the construction of medical and educational facilities.
