I am currently on record with your office as a candidate for Palm Beach County Commission, District 5 for the 2020 election cycle.

Together with this letter, I am filing documents to re-designate my candidacy with your office as a candidate for Palm Beach County School Board, District 3 for the 2022 election cycle. I will no longer be a candidate for Palm Beach County Commission, District 5 for the 2020 election cycle.

During my time as a candidate for Palm Beach County Commission, District 5 for the 2020 election cycle, I raised \$63,049.30. During the same period, I expended \$40,982.02. Accordingly, the pro-rata share for contributors requesting a refund of their contribution for the 2020 election cycle is 35%.

In compliance with Section 106.021(1) (a), letters to my 2020 contributors will be mailed within fifteen (15) days of my filing with the Palm Beach County Supervisor of Elections. The detailed letter includes all information required by statute so that the donor can make a timely and informed decision regarding a refund. Further, a copy of form DS-DE 86 (Request for Return of Contribution) is included with each letter.
