Dear Mr. Faqouseh:

The City Council at its regular meeting on Wednesday, January 2, 2019 approved your appointment as a member on the Environmental Committee. The Mayor and Council thank you for volunteering to serve on this board. Your appointment is effective until January 2, 2021.

As a member of the Environmental Committee, you are subject to the requirements under the Florida Government in the Sunshine Law. Under the law, a meeting constitutes any gathering of two or more members of the same board to discuss some matter which will foreseeably come before that board for action. As such, board members are specifically precluded from engaging in private discussions with each other about board business either in person or by telephone, e-mail, text or any other form of electronic communication. Individual board members may discuss board business with staff or a non-board member as long as the individual is not used as a liaison to communicate information between board members. For your convenience, I have included a memorandum drafted by our outside counsel regarding the Sunshine Law and its requirements with this correspondence. The memorandum will hopefully answer any questions you may have regarding the "do's and don'ts" of the Sunshine Law.

On behalf of the Mayor and members of City Council, allow me to thank you for making a difference in our great city and in the lives of those who visit, work and live in the City of New Port Richey.
