Dear Mr. Stanton:

Thank you for filing your final treasurer's report. When auditing the report, my staff found that you filed a waiver of report instead of a complete termination report reflecting the closing of your campaign account. According to the P1-06 report, your summary sheet listed your total monetary expenditures to date as \$192.00 and your total monetary contributions to date as \$200.00 leaving a balance of \$8.00 in your campaign account.

Therefore, you should have filed a termination report listing an \$8.00 expenditure with you as the vendor for repayment of the loan you made to open your campaign account. In order for your account to be closed, it is necessary for line items 9 and 10 to balance. You will be able to balance these items by filing an amendment to your TR-G report. Copies of your P1-06 and your TR-G waiver have been enclosed as confirmation of the discrepancy.

Pursuant to Section 106.07(2)(b)(1), Florida Statutes, you have three (3) days from the date of receipt of this notice to file an amended report. Failure to file a complete report after such notice constitutes a violation of Chapter 106. If you have any questions regarding this matter, please contact Tiffannie at your earliest convenience.
