Dear Ms Martinez:

Thank you for filing your final treasurer's report. When auditing the report, my staff found that the total monetary expenditures to date do not balance against the total monetary contributions to date. Your report shows a difference of \$858.50 between line item (9) and line item (10). In order for your account to be closed, it is necessary for those two items to balance. A copy of your TR-G summary sheet has been enclosed as confirmation of the discrepancy.

It appears the discrepancy in your report is due to the item listed on your contribution sheet of \$429.25. If this entry was actually the money left in the account that was used to pay back monies contributed to the campaign account by Mr. Martinez, the entry should have been reported as a monetary expense on the expenditure sheet instead of the contribution sheet. If so, you need only amend your termination report to remove the contribution by changing its amount to \$0.00 and adding the entire item to the expenditures.

Pursuant to Section 106.07(2)(b)(1), Florida Statutes, you have three (3) days from the date of receipt of this notice to file an amended report. Failure to file a complete report after such notice constitutes a violation of Chapter 106. If you have any questions regarding this matter, please contact Tiffannie at your earliest convenience.
