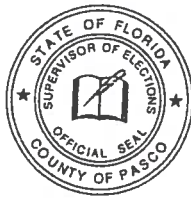

4. Attached are 2 documents that show that my nickname is one by which I am generally known or is one that I have used as part of my legal name: Business card and prior campaign literature

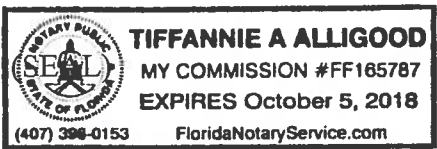
