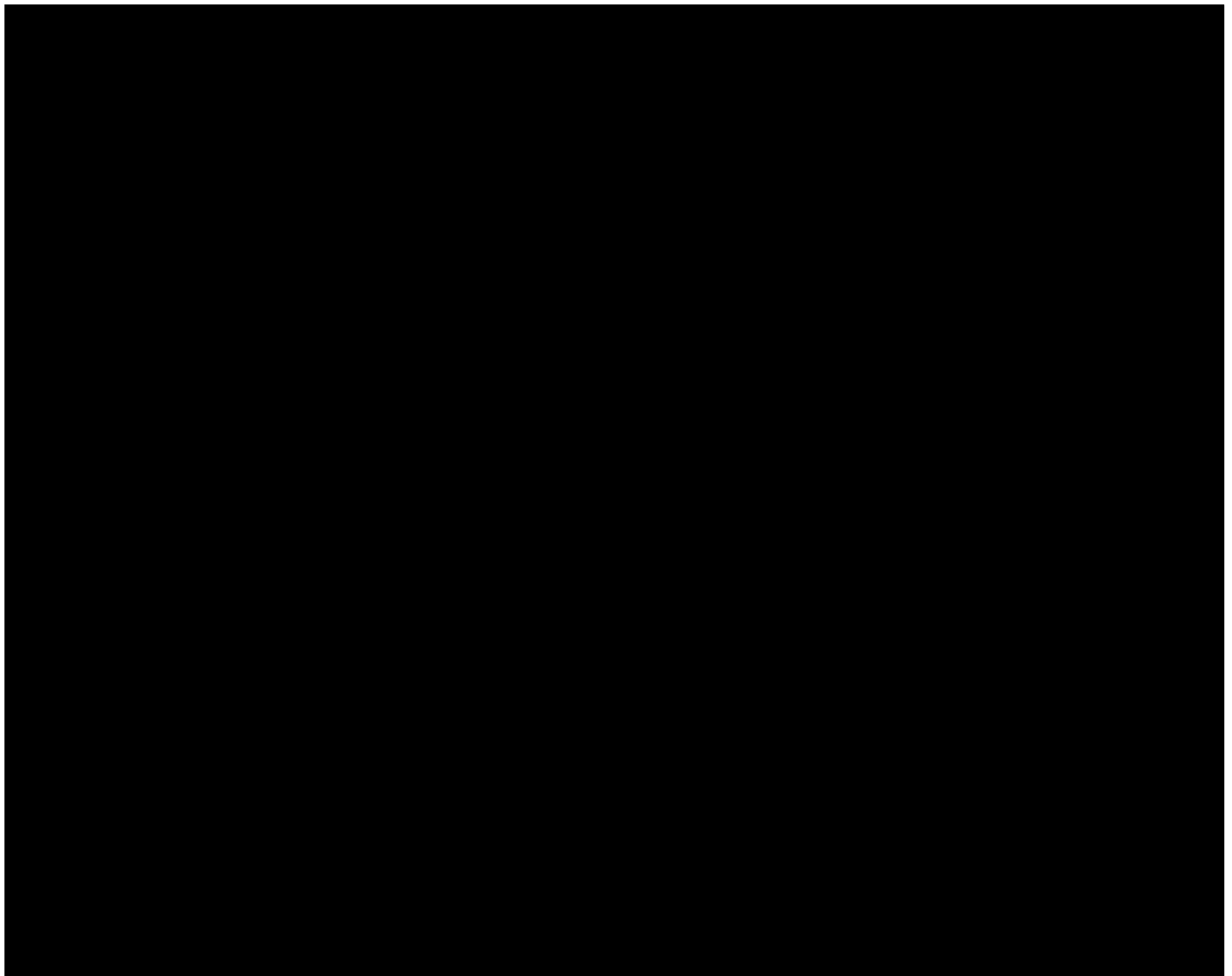


Nominees from the June 6 meeting were:

3. Robert Martinez - 6

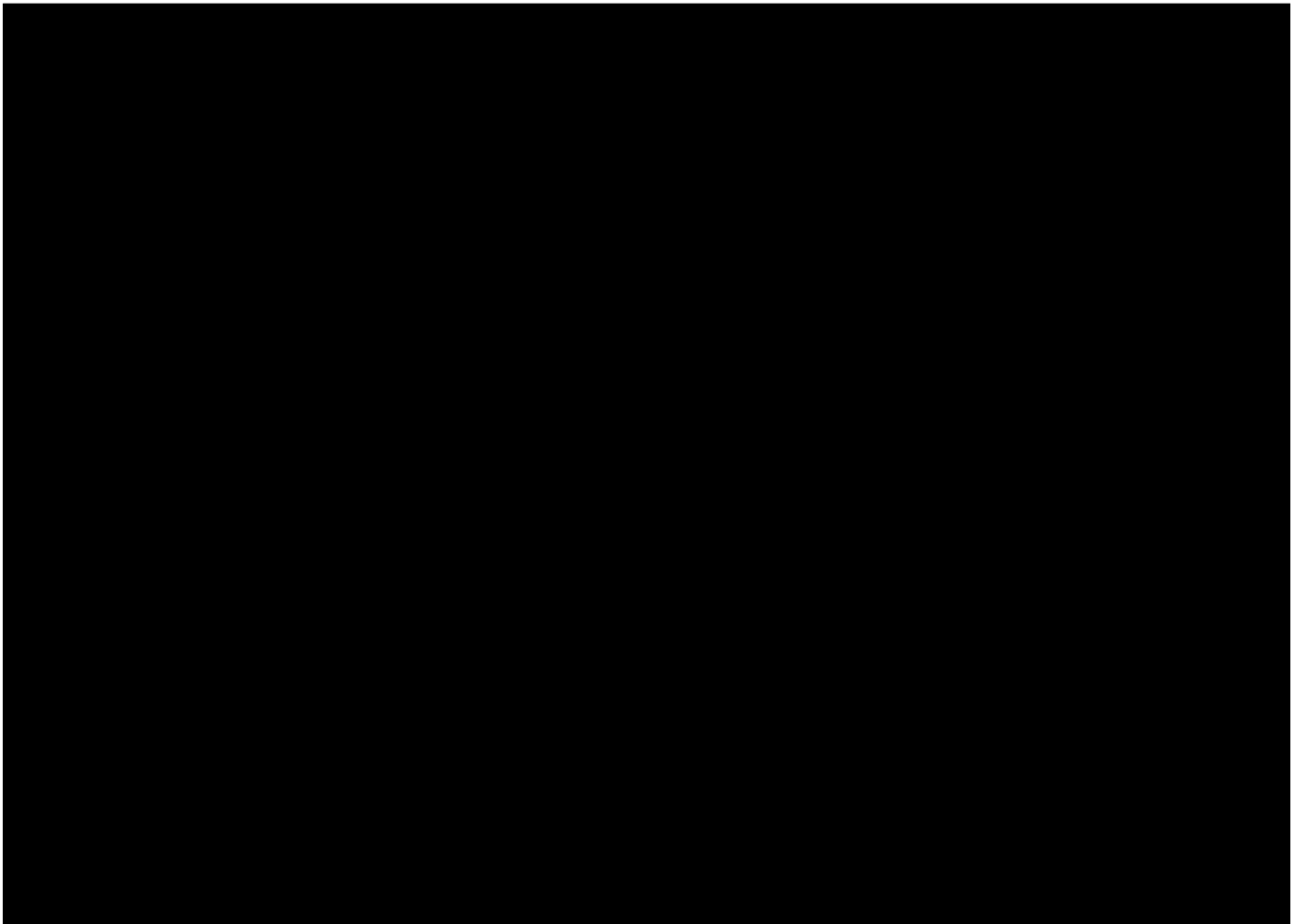
Richard Lubin was congratulated as the winner and will be added to the REC Bank Account and SOE Filing System as soon as possible.
