<u>Acknowledgment</u>: The City Clerk must require each person given a secure sign-on to the electronic filing system to sign a written statement on a form prepared by the City Clerk acknowledging the following:

### (Initials)

(a) Campaign finance reports must be completed and filed through the County's electronic filing system not later than midnight of the day required by law therefore.
(b) Campaign finance reports not filed by midnight of the required day are deemed late-filed and are subject to the penalties prescribed under Section 106.07(8), Florida Statutes.



(c) Campaign finance reports filed through the County's electronic filing system are considered to be certified as to correctness within the meaning of Section 106.07(5), Florida Statutes, by the candidate and the candidate's treasurer, in the case of a candidate, or the political committee's chair and treasurer, in the case of a political committee, and such persons are subject to the provisions of Section 106.07(5), Florida Statutes.



(d) The person signing the statement is responsible for protecting the sign-on credentials from disclosure, and for all filings using such credentials, unless the person has notified the Supervisor that such credentials have been compromised.
